Terms of Enrollment

- A non-refundable deposit of \$100 is required per camper, per camp to hold the camper's place. This amount is deducted from the total camp fee. You may choose to pay the full fee at time of registration, in which case, no deposit is required.
- The balance of each camp fee is due the first day of the month that the camp is in. Balances may be mailed in, paid over the phone with a credit card or paid in person.
- A full week's notice is required for cancellation of a camp. If IAIS is notified one full week in advance that a camper is being withdrawn from a camp, a full refund (minus non-refundable deposit) will be paid. If less than a full week's notice is given, no refund will be possible.
- A separate registration form and signed Terms of Enrollment is required for **each camper**. The forms may be photocopied.
- For your child's safety, if any portion of the registration form is left blank, it will be returned until it is completed. If IAIS does not have a completed registration form by the first day of your child's camp, one will be provided for you to fill out on-site. If IAIS does not have a completed registration form by the end of the first day of your child's camp, we will not be able to keep your child enrolled.
